Subj: DISESTABLISHMENT OF COMMANDING OFFICER, HELICOPTER ANTI-SUBMARINE SQUADRON TEN (HS-10) AND MODIFICATION OF COMMANDING OFFICER, HELICOPTER SEA COMBAT SQUADRON THREE (HSC-3)

1. <u>Purpose</u>. To approve disestablishment and modification of subject fleet activities per reference (a).

2. <u>Background</u>. Per references (b) and (c), HS-10 serves as the Pacific Fleet Replacement Squadron (FRS) for SH-60F/HH-60 aircraft and HSC-3 serves as the Pacific FRS for MH-60 aircraft. Per Master Aviation Plan (11-02), HS-10 will disestablish due to upcoming aircraft end of service life. HS-10 will shift its remaining legacy SH-60F/HH-60H FRS personnel, resources, aircraft, and equipment, to HSC-3 at NAS North Island. HSC-3 will become the West Coast FRS squadron for HSC (MH-60S) carrier/expeditionary squadrons, legacy HS (SH-60F/HH-60H) squadrons until transition to HSC, and HSC-84/85 (HH-60H) reserve squadrons that provide Naval Special Warfare/Special Operations Forces (NSW/SOF) support.

3. Organizational Changes.

a. Effective 30 September 2012, disestablish HS-10. The following applies:

b. Revised Training Mission Aircraft Assignment. Reference (c) is Required Operational Capability (ROC) and Projected Operational Environmental (POE) for HSC-3 which lays out the FRS training mission requirements. HSC-3 is currently assigned as the FRS for MH-60S aircraft. Effective 30 September 2012, HSC-3 is assigned the additional responsibility as the FRS for SH-60F and HH-60H Type-Model-Series aircraft.

d. OPNAV Resource Sponsor. OPNAV N98/N43

4. Action

a. Per reference (a) Commander, U.S. Pacific Fleet / Commander, Naval Air Force, U.S. Pacific Fleet / Commander, Helicopter Sea Combat Wing Pacific will take appropriate action to disestablish HS-10. Transfer the remaining FRS production of personnel, resources, aircraft (SH-60F/HH-60H) and equipment to HSC-3. FRS training for HS squadrons will sundown upon the final HS squadron transition to HSC (MH-60S). Ensure that HSC-3 is properly manned, fully trained, capably equipped, and well maintained to carry out the West Coast FRS production for the MH-60S, SH-60F, and HH-60H type-model-series aircraft per Master Aviation Plan. Submit required changes to update reference (c) the Required Operational Capability (ROC) and Projected Operational Environmental (POE) for HSC-3.

a. This is advance change 39-12 to reference (d).

b. Master Update Authority, Honolulu, HI will delete the Plain Language Address (PLA) in the Central Directory Component effective 30 September 2012 unless otherwise directed via official correspondence.
