Subj: ESTABLISHMENT OF OFFICER IN CHARGE, HELICOPTER SEA COMBAT

SQUADRON TWO ONE DETACHMENT (HSC-21 DET) SCORE

- 1. <u>Purpose</u>. To approve establishment of subject fleet detachment per reference (a).
- 2. Background. Chief of Naval Operations directed Naval Reserve Force squadrons HSC-84 at NAS Norfolk and HSC-85 at NAS North Island to shift its primary mission area to dedicated Special Operations Forces (SOF) support. Commander, Naval Air Force, U.S. Pacific Fleet / Commander, Naval Air Force Reserve directed HSC-85 to transfer the Southern California Off-Shore Range (SCORE) mission, manpower, resources, and equipment to HSC-21. Commander, Helicopter Sea Combat Wing Pacific directed HSC-21 to establish HSC-21 DET SCORE to support USN/USMC training on the SCORE complex. This SCORE mission will be in addition to the standard mission stated in reference (b) the Required Operational Capability (ROC) and Projected Operational Environment (POE) for HSC-21 as an MH-60S expeditionary squadron.
- 3. Organizational Changes.
- a. Effective immediately, $\mbox{HSC-21}$ DET SCORE is established. The following applies:

Perform CNO Special Projects, Search and Rescue (SAR), CVN support, combat logistics, torpedo recovery, target launch/recovery, aerial firefighting and other missions as assigned in the Southern California (SOCAL) operations area.

4. Action

- a. Per reference (a) Commander, U.S. Pacific Fleet / Commander, Naval Air Force U.S. Pacific Fleet and Commander, Naval Reserve Force / Commander Naval Air Force Reserve will take appropriate action to execute a mission and budget based transfer of SCORE billets, resources, and equipment from HSC-85 to HSC-21. Commander, U.S. Pacific Fleet / Commander, Naval Air Force U.S. Pacific Fleet will ensure HSC-21 DET SCORE is properly manned, fully trained, capably equipped, and well maintained as a combat support unit to meet the SCORE mission requirements. The SCORE mission requirements should be included into the next update of reference (b) or promulgated as a detachment mission functions, and tasks directive.
 - b. This is advance change 37-12 to reference (c).
- c. Master Update Authority, Honolulu, HI will add the Plain Language Address (PLA) in the Central Directory Component effective immediately unless otherwise directed via official correspondence. Correspondence concerning the PLA should be

forwarded to Commander, Naval Network Warfare Command (COMNAVNETWARCOM) (Network Operations 321), 2555 Amphibious DR, BLDG 1265, Joint Expeditionary Base Little Creek-Fort Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. - 5. Cancellation Contingency. This notice will remain in effect for one year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
