- 1. <u>Purpose</u>. To approve the modification of FMP MOCC GOLF per reference (a).
- 2. <u>Background</u>. Commander, Patrol and Reconnaissance Group recommended FMP MOCC GOLF transfer from the Reserve Component (RC) to the Active Component (AC) in preparation for future transition to a Mobile Tactical Operations Center (MTOC) that will directly support P-8A aircraft squadrons. In support of the Navy Master Aviation Plan (11-02), Commander, Naval Reserve Force / Commander Naval Air Force Reserve will transfer FMP MOCC GOLF to Commander U.S. Pacific Fleet / Commander, Naval Air Force, U.S. Pacific Fleet. FMP MOCC GOLF will continue to provide TACMOBILE support to P-3C squadrons and transition to an MTOC when Pacific VP squadrons transition from P-3C to P-8A aircraft in the future.
- 3. Organizational Change. Effective 1 July 2012, modify Fleet Maritime Patrol Mobile Operations Control Center GOLF. The following applies:

Per reference (a) Commander, U.S. Pacific Fleet / Commander, Naval Air Force U.S. Pacific Fleet and Commander, Naval Reserve Force / Commander Naval Air Force Reserve will take appropriate action to execute a mission and budget based transfer of FMP MOCC GOLF billets, resources, and equipment from Budget Submitting Office (BSO) 72 to BSO 70. Commander, U.S. Pacific Fleet / Commander, Naval Air Force U.S. Pacific Fleet will ensure FMP MOCC GOLF is properly manned, fully trained, capably equipped, and well maintained as a combat support unit to meet the TACMOBILE requirements of VP squadrons.
