1. <u>Purpose</u>. To approve the disestablishment of Naval Mobile Construction Battalion (NMCB) Two One (NMCB TWO ONE), NMCB TWO THREE, NMCB TWO FOUR, NMCB TWO SIX, and NMCB SEVEN FOUR, per reference (a).

2. <u>Background</u>. The disestablishment of the five NMCBs is due to manpower reductions to the current Selective Reserve Force. The full time support personnel in each effected battalion will be reassigned to other reserve billets.
