1. Purpose. To approve the disestablishment of Commander, TWO FIVE Naval Construction Regiment $(25^{th} NCR)$, per reference (a).

- 2. <u>Background</u>. The disestablishment of $25^{\rm th}$ NCR is a result of Program Objective Memorandum 13 billet reductions.
- 3. Organizational Change. Effective 30 September 2013, disestablish 25th NCR. The following applies:

4. Action

- b. Master Update Authority, Honolulu, HI will delete the PLA in the Central Directory Component effective 30 September 2013 unless otherwise directed via official correspondence. - 6. <u>Cancellation Contingency</u>. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
