NAVY EXPEDITIONARY INTELLIGENCE COMMAND DETACHMENT DAM
NECK

1. Purpose. To approve unit identification code (UIC) modification and detachment establishment for Navy Expeditionary Intelligence Command (NAVEXINTCOM), per reference (a).

2. Background. This action is to establish a new shore UIC for NAVEXINTCOM for all civilian billets and a portion of the military billets currently assigned to NAVEXINTCOM UIC 40623. The UIC will be reassigned to the NAVEXINTCOM Detachment Dam Neck established by this action, which will be the deployable part of unit. This change will clarify the deployable UIC from the non-deployable UIC and make readiness reporting more accurate.

3. Organizational Changes. Modify UIC assignment of NAVEXINTCOM and establish command detachment effective immediately. The following applies:

4. Action

a. Commander, U.S. Fleet Forces Command will coordinate
subject UIC change for NAVEXINTCOM, including updates required
for manpower systems, and will take appropriate action to
establish the command detachment as outlined above.

b. Master Update Authority, Honolulu, HI will add the
detachment PLA in the Central Directory Component effective
immediately unless otherwise directed via official
correspondence. Correspondence concerning the PLA should be
forwarded to Naval Network Warfare Command (NAVNETWARCOM)
(Network Operations 321), Bldg. 1265, Joint Expeditionary Base,
Virginia Beach, VA 23459-5000 or by calling (757) 322-1149-1150.
Newly established detachment should be activated on Navy
Regional Enterprise Message System (NREMS). Information on
NREMS can be obtained at <https://navalmessaging.nmci.navy.mil> or
by contacting NAVNETWARCOM at numbers above.

c. This is advance change 6-13 to reference (b).

d. Director, Navy Staff, Organization and Management Branch
(DNS-33) will revise reference (b).

5. Records Management. Records created as a result of this notice, regardless of media or format, shall be managed per Secretary of the Navy Manual 5210.1 of January 2012.

6. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
