Subj: DISESTABLISHMENT OF PERSONNEL SUPPORT DETACHMENT ATLANTA,
MARIETTA, GA

1. Purpose. To approve disestablishment of Personnel Support Detachment (PSD) Atlanta, a shore activity detachment, per reference (a).

2. Background. This Commander, Navy Installations Command (CNIC) action to disestablish PSD Atlanta is the result of the customer base at Atlanta being reduced through base realignment and closure actions to the point where, per Navy Pay and Personnel Support Center policy, a customer service desk (CSD) is the proper level of support rather than a PSD. Chief of Naval Operations action will disestablish the PSD, preserving the current unit identification code (UIC) and CNIC will establish a CSD with the UIC. There is no reduction in force of civilian personnel as a result of this action, and the officer in charge billet will be cut and replaced by a civilian personnel officer under the CSD.

3. Organizational Changes. Disestablish PSD Atlanta effective immediately. The following applies:

4. Action

a. CNIC will take appropriate action to disestablish PSD Atlanta and establish a CSD in its place.

b. Master Update Authority, Honolulu, HI will delete the PSD PLA in the Central Directory Component effective immediately unless otherwise directed via official correspondence. Correspondence concerning the PLA should be forwarded to Commander, Naval Network Warfare Command (NAVNETWARCOM) (Network Operations 321), Bldg. 1265, Joint Expeditionary Base Little Creek Fort Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. NAVNETWARCOM will coordinate removal of the PLA in the Defense Messaging Service system with applicable Navy Computer and Telecommunications Area Master Station.

c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
