1. <u>Purpose</u>. To approve the change in permanent duty station (PDS) for Commander, Naval Special Warfare Group (COMNAVSPECWARGRU) THREE, per reference (a).

- 2. <u>Cancellation</u>. OPNAVNOTE 5400 Ser DNS-33/12U102122 of 21 Aug 2012.
- 3. <u>Background</u>. As part of the Naval Special Warfare (NAVSPECWAR) Undersea Consolidation Initiative, and concept approval by Special Operations Command Board of Directors meeting for Phase IV of the Strategic Planning Process for Program Objective Memorandum 2010-2015, COMNAVSPECWARGRU THREE will begin a phased relocation from Coronado, CA to Pearl Harbor, HI, as part of the downsizing and consolidation of the NAVSPECWAR Undersea Enterprise.
