1. Purpose. To approve disestablishment of Naval Surface Warfare Center (NSWC) Indian Head Division Detachment Earle per reference (a).

2. Background. Base Realignment and Closure (BRAC) 2005 realigned all of the functions of the detachment to the NSWC Indian Head Division Detachment at Picatinny Arsenal, NJ. Consequently, Commander, Naval Surface Warfare Center is closing the detachment.

4. Action



a. Commander, Naval Sea Systems Command will take appropriate action to disestablish subject shore command detachment.

b. Master Update Authority, Honolulu, HI will delete the PLA in the Central Directory Component effective immediately unless otherwise directed via official correspondence. Correspondence concerning the PLA should be forwarded to Commander, Naval Network Warfare Command (NAVNETWARCOM) (Network Operations 321), Bldg. 1265, Joint Expeditionary Base Little Creek Fort Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. NAVNETWARCOM will coordinate removal of the PLA in the Defense Messaging Service system with applicable Navy Computer and Telecommunications Area Master Station.

c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
