Subj: RENAME NAVAL MARITIME FORECAST CENTER, PEARL HARBOR, HI

1. <u>Purpose</u>. To approve renaming subject shore activity per reference (a).

 <u>Cancellation</u>. OPNAVNOTE 5400 Ser DNS-33/11U228595 of 3 Nov 11.

3. <u>Background</u>. This action is required to properly reflect the mission that is being performed by the activity. Maritime forecasting responsibilities have shifted to the Fleet Weather Center San Diego, leaving the primary mission of the command as typhoon forecasting for the Pacific and Indian Ocean areas of responsibility. This action causes no change to the manning of the command, its location or the joint nature with the Air Force of the warning mission to be performed.

4. <u>Organizational Changes</u>. Rename Naval Maritime Forecast Center, Pearl Harbor, HI effective immediately. The following applies:

## 5. Action

a. Commander, U.S. Fleet Forces Command and Commander, Naval Meteorology and Oceanography Command will take appropriate action to rename subject shore activity.

6. <u>Cancellation Contingency</u>. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
