Subj: ESTABLISHMENT OF NAVAL BEACH UNIT SEVEN (NAVBEACH UNIT SEVEN); NAVAL BEACH UNIT SEVEN DETACHMENT BEACH MASTER UNIT (NAVBEACH UNIT SEVEN DET BMU); NAVAL BEACH UNIT SEVEN DETACHMENT LANDING CRAFT AIR CUSHION (NAVBEACH UNIT SEVEN DET LCAC; AND MODIFICATION OF ASSAULT CRAFT UNIT ONE DETACHMENT WESTERN PACIFIC TO NAVAL BEACH UNIT SEVEN DETACHMENT LANDING CRAFT UNIT (NAVBEACH UNIT SEVEN DET LCU)

- 1. <u>Purpose</u>. To approve the establishment of subject Fleet activity and detachments per reference (a).
- 2. <u>Background</u>. This action formally establishes NAVBEACH UNIT SEVEN as a special mission command and realigns three Japan Forward Deployed Naval Force (FDNF) detachments, ACU-1 DET WESTPAC, ACU-5 DET WESTPAC, and BMU-1 DET WESTPAC as NAVBEACH UNIT SEVEN DET LCU, NAVBEACH UNIT SEVEN DET LCAC, and NAVBEACH UNIT SEVEN DET BMU under this new command. This is a Commander Naval Surface Force, U.S. Pacific Fleet and Commander Naval Beach Group ONE zero-sum re-alignment of personnel and equipment to best support the FDNF Amphibious Ready Group (ARG) in Sasebo, Japan. All three detachments currently reside at different facilities in Sasebo. All will be centrally re-located to a new landing craft facility at Yokose that was specifically designed and built for these combat support units by the host nation.
- 3. Mission (NAVBEACH UNIT SEVEN). Conduct detachment based combat support operations as part of the Japan Forward Deployed Naval Force (FDNF) Amphibious Readiness Group (ARG) under the OPCON of Expeditionary Strike Group Seven (ESG-7)/Commander Task Force SEVEN SIX (CTF-76); provide Beachmaster Unit (BMU), Landing Craft Air Cushion (LCAC), and Landing Craft Utility (LCU) detachments that are fully trained, properly manned,

interoperable, well maintained, and combat-sustainable to conduct amphibious operations in the littoral environments. Coordinate with Naval Beach Group commands and support organizations the manning, operations, maintenance, training, logistics, administration, and support of assigned detachments.

4. Organizational Change. Effective 1 August 2012, establish NAVBEACH UNIT SEVEN, NAVBEACH UNIT SEVEN DET BMU, and NAVBEACH UNIT SEVEN DET LCAC. The following applies:

5. Action

- a. Commander, U.S. Pacific Fleet / Commander, Naval Surface Force, U.S. Pacific Fleet will take appropriate action to establish subject activity and detachments. Per reference (c), NAVBEACH UNIT SEVEN shall execute the Required Operational Capabilities (ROC) under the Projected Operational Environment (POE) for Naval Beach Group units and their elements.
 - b. This is advance change 58-11 to reference (b).
- c. Master Update Authority, Honolulu, HI will add the PLAs in the Central Directory Component effective 1 August 2012 unless otherwise directed via official correspondence.

- d. Director, Navy Staff Organization and Management Branch (DNS-33) will revise reference (b).
- 6. <u>Cancellation Contingency</u>. This notice will remain in effect for one year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
