Scope and Content

FOIA case 2009-1398-F contains responsive photos from the White House Photograph Office.

The photographs processed for this request pertain to Robert Rubin meeting with President Clinton and advisors during the period of 1995, 1996, and 1998. The photographs processed pertain to Robert Rubin meeting with the economic policy team and briefing the President on economic and budget matters. Some of the advisors in the meetings include: Vice President Gore, Laura Tyson, Leon Panetta, Larry Summers, Harold Ickes, Gene Sperling, Joseph Stiglitz, George Stephanopoulos, Alice Rivlin, Martin Baily, Don Baer, and others. Furthermore, other responsive photos include Robert Rubin being sworn in as Secretary of the Treasury on January 10, 1995 in the Oval Office, the President invoking his veto

power on H.R. 2586, Temporary Increase in the Public Debt on November 13, 1995 in the Oval Office, and the President and advisors briefing Congress on the budget.
