Two partial betacam video recordings reviewed and processed.

Access

Scope and Content

The material in FOIA 2011-0068-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2011-0068-F includes two selected master tape video recordings from the White House Television Office.

President Clinton visited and greeted employees and visitors at Pat's King of Steaks restaurant in Philadelphia, PA on September 25, 1996. President Clinton is accompanied at Pat's King of Steaks with Philadelphia Mayor Ed Rendell and other local officials. President Clinton visited Mike's City Diner in Boston, MA on January 18, 2000. President Clinton is accompanied at Mike's City Diner with Senator Edward Kennedy, and Boston Mayor Thomas Menino. The run time for the video footage in Philadelphia is approximately 9 minutes and 49 seconds (MT.6052), and the run time for the video footage in Boston is approximately 5 minutes and 5 seconds (MT.11053).

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Video Recordings of the White House Television Office, and the series therein—Video Recordings Relating to the Clinton Administration. Processing is done at the Folder/Video tape level.
