1. PRO-RATE: After one month, daily rate will be pro-rated at $1 / 30$ of the monthly rate.
2. MILEAGE: Above rates include 100 free miles per day. Excess mileage will be billed at \$ .10 per mile.
3. GASOLINE is not included. Gasoline will be billed at $\$ 5.25$ per $1 / 8$ tank, except for Nissan Altima’s which will be billed at $\$ 7.75$ per 1/8 tank, or $\$ .12$ per mile if no gasoline was added during the rental.
4. TOLLS: All vehicles are equipped with toll transponders. Do not pay any tolls. You may use the automatic I-Pass lanes. You will be billed \$ 1.50 every time you go through toll plaza. Other arrangements can be made if you have your own toll transponder. Interstate 88, 355, 90, 94 and 294 are toll roads.
5. PARKING TICKETS are solely the responsibility of the Rentee. Tickets must be paid promptly and directly to the issuing entity. Rentor receives a delayed notice of parking tickets. Usually, a large penalty is accessed. Rentor will add a \$ 15.00 service charge for handling any unpaid tickets.
6. ACCIDENTS must be reported to renter immediately. Obtain all information from the other party. Fill out accident report in glove box. Make no statements as to fault.
7. INSURANCE: \$ 50,000/100,000 liability, \$ 50,000 property damage and zero deductible collision damage is included in the rate. Rentees who decline the full collision coverage will receive a $\$ 50.00$ per month credit, if the Rentor is provided with a valid insurance policy and a $\$ 500.00$ cash deposit. In this case, Rentee will be responsible for all the damage to the rental vehicle.
8. ROAD HAZARDS are not insured by the Rentor. Rentee is responsible for damage to windshield, tires and rims from hitting curbs or potholes, and any careless damage to interior or exterior of the vehicle.
9. MAINTENANCE: Mechanical repairs on the road will be covered by the Renter; however, the Renter must receive prior approval from the Rentor. Without prior approval, Renter will only reimburse Renter at a rate deemed reasonable by Renter. All reimbursable mechanical repairs must have receipts. If Rentor cannot replace a disabled vehicle within 24 hours, Rentee may obtain a replacement vehicle. Rentor will be responsible for the expenses incurred by Rentee only up to the amount of the daily rate that Renter is charging Renter.
10. LEAVING THE STATE of Illinois requires written permission in advance, unless you are planning on staying within 150 miles of Fermilab.
11. RETURN OF VEHICLE to Fermilab is the responsibility of the Rentee in case of accident or mechanical breakdown.
12. PAYMENT may be made through FNAL travel code, by direct billing to the University, by personal check or by cash.
13. DRIVERS UNDER 21 is allowed if they are sponsored Fermilab students or interns. There is an additional charge of $\$ 2.00$ per day or $\$ 60.00$ per month for insurance.
