Hurricane Jeanne Situation Report #14
October 4, 2004 (10:00 AM EDT)**

HIGHLIGHTS

- Currently, less than one percent or 21,993 customers in Florida remain without power from Hurricane Jeanne. See tables below for county outages and restoration schedules. This will be the last situation report on Hurricane Jeanne.
- The Florida Emergency Operations Center will be going to a Level-2 operating level on Tuesday. Most state employees have been sent back to their normal jobs and the utilities and federal staff are scheduled to leave. The EOC is operated by a skeleton crew for reduced hours. OEA will staff the ESF-12 desk in Orlando and at the FLEOC in Tallahassee for the rest of today and then return.

ELECTRIC INFORMATION [Report based on company websites and Florida EOC information 10/4/04 7:00 AM EDT]

- Florida Power and Light reports that the total number of customers restored now stands at 1,727,700. Currently, 9,700(<1%) remain without power. FPL has again accelerated its restoration schedule and now estimates that every customer will be restored no later than Tuesday, 10/5.
- Tampa Electric reports that it has restored power to all of its 285,000 customers who lost power due to Hurricane Jeanne.
- Outages for Florida municipals are at 11,800, while cooperatives report outages of 493 customers.
