









Download Velocity Accelerating...

iPod Became Ubiquitous




...But iPhone Dwarfs iPod







What Else is Needed?

 Open access networks (multiple app stores, low friction to get on the network)

 Open platform networks (variety of devices that connect to the networks without paying a prohibitive tax)

Highly affordable networks for consumers

 Multiple nationwide networks to spur competition and serve all constituencies (coverage, higher speed networks, flexible pricing models).

Free Minimum of 768 Kbps

» Free Service @ 768 Kbps

Service
Description:

- » Instant install, 'Fixed portable' use, nationwide coverage
- » Consumer buys CPE such as netbooks and other smart devices

Premium/Wholesale 3-6 Mbps

- » Minimum 3 Mbps service
- » Instant install, 'Fixed portable' use, nationwide coverage
- » Enables nationwide roaming

Net Neutrality

Open access network: no blocking of content (similar to 700 MHz "C" Block);4

Open platform network: no proprietary end-user equipment (similar to 700 MHz "C" Block);5

Universal Access Nationwide Free Broadband Service: at least 25% of the network capacity dedicated to a free (no monthly subscription charge or other fees) service with a minimum of 768 kbps (download) which is the FCC's definition of basic broadband;6

Aggressive build out requirements: coverage of 50% of the population in 4 years; 95% within 10 years (with license revocation as a remedy for failure to comply).7

...Developing alternative types of networks will drive investment in new mobile apps.
