PRODUCTS & SERVICES

Document Alert

The IRC distributes this bulletin free to subscribers. Document Alert provides information on recent electronic documents and articles from major U.S. periodicals, covering topics such as: democracy and human rights, economic security and trade, environment, and international security. eJournal USA

The U.S. Department of State publishes a monthly electronic journal available in multiple languages. The journal features materials on American life, U.S. politics, economics and trade, democracy, peace and security, and science and health.

Reference and Information Research

The IRC provides research and reference on virtually all aspects of United States policy, with a focus on foreign relations, media issues, social, economic, and political issues, the rule of law, legislative developments, and current affairs.

Group Presentations

For selected professional groups, IRC staff can arrange for a hands-on presentation on IRC resources and services.

REFERENCE COLLECTION

The regularly updated reference collection is non-circulating. Visitors to the IRC have access to over 400 specialized reference publications and general encyclopedias, handbooks, and directories.

ON-LINE RESOURCES

The IRC maintains access to the following on-line resources to respond to your information needs:



ProQuest provides access to full-text or abstracts of articles from over 5,000 journals, periodicals and newspapers, including a broad range of topics from art and entertainment to business and public policy. Many are full-text, full-image format.



JSTOR is a not-for-profit organization with a dual mission to create and maintain a trusted archive of important scholarly journals, and to provide access to these journals as widely as possible. JSTOR offers researchers the ability to retrieve high-resolution scanned images of journal issues and pages as they were originally designed, printed, and illustrated. The hundreds of journals archived in JSTOR span many disciplines.



Factiva accesses over 8,000 publications in 22 languages, including Dow Jones, Reuters and Associated Press newswires, as well as data on 20,000 companies.



LexisNexis offers on-line full-text access to U.S. federal and state legislation and regulations, treaties, and legal periodicals (United States Code Service, United States Public Laws, Code of Federal Regulations and the Federal Register). Also included are full-text articles from over 1,000 newspapers, wire services, and news and business magazines.



Gale Virtual Reference Library offers more than 800 reference sources from multiple publishers allowing libraries to provide respected authoritative essays on varied topics from numerous subject areas: biography, business, education, general reference, history, information and publishing, law, literature, multicultural studies, and religion.

InfoTrac® OneFile is a one-stop source for news and periodical articles on a wide range of topics: business, computers, current events, economics, education, environmental issues, health care, hobbies, humanities, law, literature and art, politics, science, social science, sports, technology and many general interest topics.

Biography Resource Center combines biographies from respected Gale Group sources. It also includes full-text articles from hundreds of periodicals.



CQ Researcher offers in-depth, non-biased coverage of today's most important issues. Each report is on a single topic—more than 12,000 words of text and extensive bibliographies. Each weekly issue provides up-to-date information on controversial subjects written by CQ's staff of experienced reporters.



Leadership Directories provides online access to directories of the Congress, federal, state and municipal government, law firms, NGOs, judicial, media and associations.
