Note: The Division will regularly be updating the list of fully licensed independent licensees and pending independent licensee applicants which are eligible to conduct activities. However, the list will **not** be updated daily, so if you have any questions regarding the eligibility of the company with which you are dealing to conduct activities, you should contact the Division.

Homeowners: The above Chapter 645F fully licensed independent licensees may conduct, and pending independent licensee applicants **are eligible** to conduct, activities of a loan modification consultant, foreclosure consultant or covered service provider and have deposited a surety bond or substitute form of security with the Division. **Please note: Attorneys are exempt from the provisions of Chapter 645F. You can confirm if an attorney is licensed in Nevada by searching the individual's name on the State Bar of Nevada's Web site through the attorney search option at <http://www.nvbar.org/findalawyer.asp>.** Companies which are not listed above are **not eligible** to conduct activities unless otherwise exempt. If you are dealing with a company which is **not** listed above, you should contact the Division to determine if the company is exempt from licensing requirements. If the company is not exempt from licensing requirements, you should contact the company with which you are dealing to transfer your files, moneys and contracts to a fully licensed, bonded independent licensee or bonded independent licensee applicant, HUD-approved counseling service or other company exempt from licensing requirements. If you are unable to reach the company with which you are dealing, or if the company refuses to transfer your files, moneys and contracts, you should complete the [Consumer Complaint Form](#) which is posted on the Division's website, www.mld.nv.gov, under the Forms link, and submit it to the Division so that the Division may conduct an investigation and take administrative and disciplinary action, as appropriate.
