- 1. Welcome Chair. 4:38 pm, meeting called to order.
- 2. Old Business
- a. Review and approval of October meeting minutes Secretary The minutes were unanimously approved.
- b. Seating of newly elected members The chair welcomed, newly elected parent representative and Mr., the newly elected teacher representative.
 - c. Review of election process Chair
- 1) The election was completed using an on-line survey tool (SurveyMonkey) in accordance with the guidelines.
- 2) Challenges included ensuring a valid and complete e-mail list.
- 3) The voting appears to have been successful as 188 people participated as compared to about 20 people voted last year.
- 4) It should be noted that 68% of the teachers without students in the school participated.
- 5) SurveyMonkey was easy to use and received positive feedback from the users; the intent is to put a protocol in place to run successful elections next year.

- 1) The committee examined the data posters on display in NMHS hallways.

- 2) A parent representative asked Data POC and the administration to publish more data on the website.
- 3) The data POC will run a correlation of course grade to AP score in the effort to determine to what extent course grade predicts AP exam score?
- 4) The POC will explore the feasibility of splitting science vs. humanities.
- 5) Parent Question: If students are taking an AP course, a college-level classroom instruction is expected, but is college-level understanding being developed? How do we give consumers enough information to make educated choices about which AP classes to take?
 - e. ASPEN information pathways Vice-Principal [3.a.2.c]
 - 1) Progress reports were sent mail.
- 2) On Monday, Wednesday and Friday, login's are issued pretty regularly to parents.
- 3) Parents noted that getting locked out of their account is a major issue as it takes intervention from the school to restore access. Parents are supposed to be able to request assistance via the HELP button on the website. Several parents noted that they had used the button to report a problem but had not received a response or resolution.
- 4) Security features. The keyboard is now stationary. Some login difficulties stem from the fact that we have to follow school and DoDEA security features.
- 5) Technical. ASPEN works better on Google Chrome and teachers and parents are having fewer errors and delays with that browser. The server is in Georgia so that causes difficulties. Teachers and parents are both still receiving error pages. DoDEA has a web page set up for submitting problems.
- 6) Action Item: (Vice-Principal) What happens to the error messages sent to ASPEN?
- 7) We keep pushing up to district what is out of our control. Far more information will be available to parents in this program; triggers are available now and things are getting better so stick with us!
- 8) Parents should contact the vice-principal is access is not restored within two weeks.
