Dear Mr. O'Dowd:

We have reviewed the changes to New Hampshire Radioactive Materials License No. 439R, received by our office in a letter dated September 27, 2004 and issued to Quality Assurance Laboratories, Inc. In addition, we have also reviewed the proposed changes to New Hampshire regulations, Chapter He-P 4039 in your second letter dated September 27, 2004. Our review and comments are in response to the State's request for Nuclear Regulatory Commission (NRC) evaluation of the license conditions in New Hampshire Radioactive Materials License No. 439R and proposed regulations in Chapter He-P 4039 that incorporated the two amendments identified on the States Regulation Status Data Sheet (SRS). These regulations were reviewed by comparison to the equivalent NRC rules in 10 CFR Parts 34, 36 and 39. We discussed our review of the license conditions with you on October 4, 2004.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if the regulations in He-P 4039 are adopted without significant change, they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200. Regarding the changes to New Hampshire Radioactive Materials License No. 439, since those regulations that are incorporated by license condition into an active license, we have concluded they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200 and no further correspondence on this matter is needed.

The SRS Data Sheet summarizes our knowledge of the status of other New Hampshire regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
