We received Ohio's email response dated December 21, 2006 to our All Agreement State letter ([FSME-06-110](#)) dated December 12, 2006, regarding the implementation of the National Source Tracking System (NSTS) requirement to assign serial numbers to each nationally tracked source. According to FSME 06-110 any State that has licensees that are authorized to manufacture sources subject to tracking in the NSTS will need to take appropriate action to implement this requirement on or before February 6, 2007. From your response we understand that Ohio does not have any licensees which meet these conditions and, therefore, Ohio does not need to implement this requirement at this time. However, should Ohio in the future, acquire a licensee which is authorized to manufacture sources subject to the tracking in the NSTS, Ohio would need to take actions to implement these requirements at that time.
