Dear Mr. Owen:

We have reviewed the proposed changes to the final Ohio regulations 3701:1-46-05 of the Ohio Administrative Code, received by our office on April 10, 2007. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 30, 31, 32 and the requirements of the one amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Michael Snee on April 24, 2007.

As noted in All Agreement States letter [STP-05-072](#), dated September 28, 2005, NRC staff will continue to hold in abeyance any determination on those rules and compatibility of 10 CFR 31.5 and 31.6, if the Agreement State has the essential elements of the NRC's rule and is more restrictive than the NRC's rule.

In our August 31, 2006 letter to you we had three comments. Comments one and two were less restrictive than NRC's regulations, while Comment three was more restrictive than NRC's regulations. After reviewing your submission we have determined that your regulations have been changed to incorporate Comments one and two. However, since Comment three was more restrictive Ohio chose to take no action at this time. Until such time as a decision on the petition for rulemaking, as discussed in [STP-05-072](#), is reached, no corrective action will be required for this comment.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in FSME Procedure [SA-201](#), "Review of State Regulatory Requirements," please highlight the final changes, and provide a copy to Division of Materials Safety and State Agreements, FSME.

The SRS Data Sheet summarizes our knowledge of the status of other Ohio regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
