Dear Mr. Snee:

We have reviewed the final revision to the Ohio regulations in the Ohio Administrative Code, received by our office on November 9, 2010. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 20, 30, 31, 32, 33, 35, 40, 61, 70, 150 and the requirements of the three amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on January 11, 2011.

As a result of our review, we have three comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that if these regulations are revised, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure [SA-200](#).

We request that when you revise your regulations to address our comments, a copy of the "as published" regulations be provided to us for review. As requested in FSME Procedure [SA-201](#), "Review of State Regulatory Requirements," please highlight the location of any changes made by Ohio, in response to our comments, and provide a copy to Division of Materials Safety and State Agreements, FSME.

The SRS Data Sheet summarizes our knowledge of the status of other Ohio regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. For the purposes of this definition, low-level radioactive waste means radioactive waste not classified as high-level radioactive waste, transuranic waste, spent nuclear fuel, <i>byproduct material as defined in paragraph (A)(26)(b) of this rule, or byproduct material as defined in section 11 E. (3) and (4) of the Atomic Energy Act of 1954, as amended.</i></p> <p>Ohio needs to make the above changes in order to meet the Compatibility Category B designation assigned to 10 CFR 20.1003.</p>
2	3701: 1-40-13	30.20(a) 2007	3	B	<p><b>Gas and aerosol detectors containing byproduct material</b></p> <p>Ohio regulation, 3701:1-46-13(A), needs to replace the term “byproduct material” with the term “radioactive material” in the first sentence.</p> <p>Referenced in Ohio regulation 3701:1-40-13(A) and (B), regulation 3701:1-46-27, could not be located in Ohio’s Administrative Code. Ohio needs to reference the correct regulation.</p> <p>Ohio needs to make the above changes in order to meet the Compatibility Category B designation assigned to 10 CFR 30.20.</p>
