## Dear Mr. Broderick:

We have reviewed the final revision to the Oklahoma Radiation Management Rules, Oklahoma Administrative Code (OAC) 252:410, 2005 Edition, effective June 15, 2005, received by our office on September 20, 2005. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 20, 30, 31, 32, 34, 35, 36, 39, 40, 61, 70, 71, 150 and the requirements of the 12 amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on October 19, 2005.

As a result of our review, we have two comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that if these regulations are revised, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We also note that your cover letter states 10 CFR 71.11, Deliberate Misconduct by Unlicensed Persons, was inadvertently not adopted. However, amendments to 10 CFR 71 effective in January 26, 2004 (69 FR 3697) (RATS ID 2004-1) redesignated 10 CFR 71.11 as Reserved, moving the Deliberate Misconduct section to 10 CFR 71.8. Your letter states that the process to adopt 71.11 by reference will begin and be in effect by June, 2007. Since RATS ID 2004-1 is due for adoption by all Agreement States by October 1, 2007, Oklahoma should consider making all of the necessary changes.

We request that when you revise your regulations to address our comments, a copy of the "as published" regulations be provided to us for review. As requested in STP Procedure SA-201, "Review of State Regulatory Requirements," please highlight the location of any changes made by Oklahoma, in response to our comments and provide a copy to STP.

The SRS Data Sheet summarizes our knowledge of the status of other Oklahoma regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
