We have reviewed the final revisions to the Washington Air Emissions Regulations WAC 246-247 and WAC 246-248, received by our office on October 20, 2006. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Part 20 and the requirements of one amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Al Conklin on November 21, 2006.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure [SA-200](#).

Please note we previously reviewed these regulations in final form with no comments, on October 25, 1999. Since the current review is the result of a restructuring of the regulations and we have no comments, we will not need to re-review these regulations unless additional changes occur before the regulations are issued.
