

Bid Schedule B Project: WY PFH 26-1(3) SAGE CREEK ROAD

(j) <u>Add the following:</u>

For time periods not approved for road closures (as listed in Section 108.01) the contractor shall limit construction delays during daylight hours. Maintain alternate one-way operations with flaggers and/or pilot cars and/or traffic signals with traffic delays in either direction not exceeding 30 minutes per passage through the entire project, or provide scheduled pilot car operation(s) for each direction for 15 minutes every hour on the hour. If a consistent cycle time is not maintained either due to the volume of traffic or due to the contractor's own operations, reduce the length of the alternate one-way operation such that a consistent cycle time can be met.

Unless shown in the temporary traffic control plans, maintain continuous two-way traffic during non-daylight hours.

Limit alternate one-way operations, with flaggers only, to a maximum of four separate operations with a maximum total combined length of 4000 feet. Reduce the length of one-way flagger operations as required to limit traffic delay to 30 minutes per passage through the entire project.

The above authority to delay traffic will be contingent upon strict adherence of the Contractor to the agreed schedules, and upon maintenance of satisfactory road conditions for the passage of traffic through the work.

Provide access through the work zone immediately upon arrival at the job site for emergency vehicles, including those carrying County, State, and U.S. Government personnel responding to emergency situations. Be prepared at all times to immediately cease construction operations and restore the roadway such that emergency passage can be afforded such vehicles at any time regardless of the traffic control plan in effect.

Provide access through the work zone to authorized permittees for livestock grazing. Prior notice must be received at a minimum of two days before.

156.08 Traffic and Safety Supervisor. Delete the first paragraph and substitute the following:

Provide a traffic and safety supervisor who is certified by the State highway agency or other acceptable certification program. Furnish the traffic safety supervisor's name, address, and 24-hour telephone number(s) at the preconstruction conference. At all times during the contract, including periods of suspensions and work stoppages, perform all of the following:

Section 157. – SOIL EROSION CONTROL

Material

157.02 Add the following:

Slope drainage pipe

706.08(d)

157.03 General. Delete the Subsection and substitute the following:

(a) 25 percent of the unit bid price will be paid upon installation.

(b) An additional 50 percent of the unit bid price will be prorated based on total work complete.

(c) Payment of the remaining 25 percent of the unit bid price will be paid when the temporary erosion control and sediment measures are removed from the project.

Section 201. - CLEARING AND GRUBBING

Construction Requirements

Add the following:

Timber

All merchantable timber must be cut and removed; non-merchantable trees, tops, and limbs will need to be piled by the contractor, as directed by the CO, for later burning by the Forest Service. After the clearing limits are staked by the contractor following award of the construction contract, the Forest Service will mark the merchantable trees to be cut and removed. The contractor shall make a payment of \$6350.00 to the Forest Service, by electronic funds transfer, as compensation for the merchantable timber and brush disposal expenses incurred by the Forest Service.

Slash Treatment

Slash is defined as logs, tops, limbs, and other woody material, exclusive of stumps, created by the logging operation and which remains on the ground after logging. In areas where contactor-created slash is intermingled and inseparable from pre-existing slash, slash disposal requirements apply to the preexisting slash as well as contractor-created slash.

The Contractor will be expected to perform the slash disposal work described in the following according to a schedule developed with the Forest Service.

Cutting Units	Type of Slash Disposal
All	Contractor should leave tops and limbs of felled trees attached to Included Timber and yard them to landings
	within the cutting unit. Tops and limbs which are lost on the way to the landing due to normal felling,
	skidding operations, etc. are not required to be yarded.
All	A landing is any place where logs or products are gathered for loading. Logs not meeting utilization
	standards at landings shall be piled. Piles shall be at least 50' from residual trees. They must also be compact
	and dirt free. The minimum pile height is 10', unless sufficient material is unavailable. Any object extending
	more than 3' from the windrow or pile should be cut off and returned to the pile.
All	Lop and scatter any incidental slash including lost tops and limbs to within 24" or less above the ground.

Slash Responsibility

201.05 Grubbing.

(b) <u>Delete the text and substitute the following:</u>

Grub all embankment areas. Undisturbed stumps less than 24 inches in diameter may be left in place if they protrude less than 6 inches above the original ground and will be covered with more than 4 feet of embankment. Remove all other stumps.

Section 203. – REMOVAL OF STRUCTURES AND OBSTRUCTIONS

Description

203.01 Add the following:

For the Sage Creek Project this work also consists of removal of existing signs along the roadway, removal of pipe culverts either in whole or partially, removal of existing cattle crossings, and removal of existing fence and existing gates.

These items have been tabulated and are included in the plans.

Construction Requirements

203.05 Disposing of Material.

(a) Remove from Project. Add the following:

All removed cattle guards shall become the property of Carbon County. The cattle guards shall be delivered to the County in Rawlins, Wyoming.

Secure environmental clearances according to Subsection 107.10.

(b) Burn. <u>Delete the text.</u>

(c) **Bury.** Delete the text.
