2009 State Alumni Member of the Month. An IVLP alumnus, he discussed the challenges facing the Committee of Experts (CoE) that is tasked with re-writing Kenya's constitution. He spoke of his observations of the U.S. system and how that has influenced what he brings to the committee. Otiende used the occasion to urge fellow alumni who have had firsthand experience with the U.S. system to support the committee's endeavors in whichever way they can to make sure Kenya gets a new

constitution. The Ambassador's urged alumni, as he has Kenyans in general, to get involved in the implementation of the reform process. In his support for the CoE, he called for "real

effort to build consensus" to help the committee succeed. He also said that Kenya had a historic opportunity to make a new constitution and that it must adopt an all inclusive approach to deliver the new document to its citizens. He promised America's support for the Kenyan people as they push for a better constitution that will root out injustice and corruption in the society.

Kenya Alumni Peace and Leadership Award

Next year the alumni office will be awarding an alumnus/ alumna for his/her outstanding leadership initiative and promotion of peace in society. All alumni are therefore invited to send their bios to the Alumni Coordinator for posting on the Kenyan community site and potential nomination.

Criteria

Alumni are invited to nominate an individual (a State Alumnus/Alumna) from either the public or private sector who they think is an exemplary leader. The top three people with the highest number of nominations will be invited to give a talk on the subject of leadership. He/she must also be a registered member of the state alumni website.

The Alumnus/a with the most nominations and convincing community involvement will receive an award worth \$1,250, out of which \$1,000 will go to a project they are involved in while \$250 will be used to buy a plaque that will go to them.

Kenyan feted Global Alumni Member of the Month for October 2009



Otiende addresses fellow alumni

For the first time since its inception, a Kenyan was feted the coveted global alumni member of the month recognition. The recognition is usually bestowed on an alumna/alumnus for his/her contributions in the community before and after his/ her experience in America.

Otiende Amollo, a 2007 alumnus of the International Visitor Leadership Program (IVLP) was feted for having dedicated his life to promoting and educating the Kenyan public about human rights, civil liberties, and fair democratic rights. He was also cited as being equally adept at explaining Kenyan constitutional law to U.S. Senators as he is securing better legal protection for HIV/AIDS patients. He credits the IVLP experience with having had a profound impact on his professional ca-

reer: "My exchange program gave me a very meaningful insight to the workings of American democracy."

In March 2009, Amollo was appointed by President (and fellow IVLP alumnus) Mwai Kibaki to rewrite the constitution of Kenya. When discussing this task, Amollo said that his IVLP experience "is helping me design what is helpful for Kenya. It also helped me understand coexistence in a multi-racial, multi-ethnic, and multi-religious community. It was a real lesson on how to diffuse the tribal divisions that exist in Kenya." As an active supporter of the alumni community in Kenya, Amollo engages in discussions organized by alumni and offers his opinions and expertise. He is therefore a role model for the younger alumni and offen engages them during alumni gatherings. He is constantly in demand by the international community to give direction on legal matters. Amollo is a natural-born leader who works to defend fellow Kenyans in the court of law, by providing direction and assistance on legal matters.

As a legal advocate, Amollo dedicates a significant amount of his time to doing pro -bono work for underprivileged members of the Kenyan society. For example, he successfully represented a person afflicted with HIV/AIDS who had been dismissed from her place of work due to her health status. As a result, the court ordered the employer to compensate the victim. This was a landmark case in Kenya and a real win for the fight against the HIV/AIDS stigma in that it established the triple principles that one cannot test an employee without his or her expressed consent; one cannot disclose the test results to the employer without expressed consent; and one cannot terminate employment on account of only the employee's HIV status. These principles are now encapsulated in the HIV Act which Amollo

spearheaded and drafted, and which has finally become law. Amollo was recently honored at a reception by the U.S. Ambassador to Kenya

who handed him a certificate for his achievements.
