SUBJECT: Bavaria Military Community Policy Letter #16; Installation Curfew Policy

- 1. Effective Date. This policy letter remains in effect until superseded or rescinded.
- 2. Scope and Punitive Effect. This policy letter is applicable to all juveniles in the USAG Grafenwoehr area of responsibility. The policy applies to dependents of military and/or DOD civilian personnel assigned to USAREUR, or who are in the legal custody of USAREUR military or DOD civilian personnel (e.g., guardianship or foster care); live on or off-post. Failure to comply with the provisions of this policy letter may result in adverse administrative action or punitive action against any person in the categories above, including punishment under the Uniform Code of Military Justice for service members.
- 3. The following curfew is in effect and applies to USAG Grafenwoehr Enterprise communities:
- a. Juveniles between the ages of 13-15 must be inside their quarters by 2200 hours Sunday through Thursday unless in the presence of their sponsor, adult Family Member, or designated adult guardian. Curfew on Friday and Saturday is extended to 2300 hours. For the purpose of this policy, an adult is defined as someone who is 18 years or older. For juveniles under the age of 13 the Child Supervision Guidelines apply.
- b. Juveniles who are 16-17 must be inside their quarters by 2300 hours Sunday through Thursday and in the presence of their sponsor, adult Family Member, or designated adult guardian. Curfew on Friday and Saturday is extended to 2400 hours.
- c. Exceptions to the above rules will be granted for specifically sanctioned activities such as DoDDS, Youth Services, MWR events, or Chapel Youth Ministries. Juveniles returning from these types of sponsored activities must go directly from the activity upon completion to their quarters.
- d. Any juvenile found in violation of this curfew will be escorted to the Military Police station at Rose Barracks if caught on Rose Barracks and the parents will be notified and will retrieve the child(ren) from the station. However, if the child(ren) is caught in Grafenwoehr the child(ren) will be escorted back home to the parents. If any juvenile is found in violation of this curfew on Sheridan or Artillery Kaserne in Garmisch, the juvenile will be escorted to the Military Police station at Artillery Kaserne and the parents will retrieve the child(ren) from the MP station. Any juvenile found in violation of this curfew found on the USAG Hohenfels post will be escorted to the Military Police Station on post and the parents will retrieve the child(ren) at the MP station.
