**US ARMY GARRISON YONGSAN COMMAND POLICY #1-12**

MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Army Substance Abuse Program (ASAP) 180 Day Incentive Award

1. **REFERENCE:** AR 600-85, Army Substance Abuse Program (ASAP), 24 March 2006.
2. **PURPOSE:** This policy provides guidance and establishes responsibilities for awarding the USAG-Y 180 Day Incentive Award to units meeting the criteria in this policy.
3. **APPLICABILITY:** This policy applies to all US Army Garrison-Yongsan (USAG-Y) tenant units participating in the USAG-Y Risk Reduction Program.
4. **GENERAL:**
  - a. The USAG-Y Commander rewards units displaying good conduct by not having an alcohol-related military police blotter incident (ARBI) for 180 consecutive days and for conducting all required monthly drug testing during the quarter. This program applies to all units participating in the USAG-Y Risk Reduction Program. Any other units in USAG-Y desiring to participate will require a written request from the unit commander to the USAG-Y Commander for inclusion in the program.
  - b. A guidon streamer will be provided to the brigade/battalion commander for presentation to the unit at the first 180 day mark and at annual intervals thereafter. It is suggested brigade/battalion commanders authorize a training holiday for each 180 day compliance period. The brigade/battalion commander will determine the training holiday date, if authorized.
  - c. The USAG-Y Alcohol and Substance Abuse Program Manager will review all USAG-Y military police blotters on a daily basis and identify alcohol-related offenders. An ARBI occurs when a Soldier is the subject in a military police blotter report that is alcohol-related. The ASAP Program Manager will notify Unit Prevention Leaders when companies qualify for the USAG-Y ASAP 180 Day Incentive Award.
  - d. The company guidon streamer will be revoked and returned to the USAG-Y ASAP Program Manager if an ARBI occurs. The company will be eligible for the streamer when the unit again achieves 180 consecutive compliant days. The unit chain of command is responsible for returning streamers to the USAG-Y ASAP Program Manager not later than the next duty day after notification of an ARBI.
