Training Program: Tribal Court Trial Advocacy Training Program

Course Description: Through lecture and practical exercises, the course will provide instruction on Trial Preparation, Direct examination, Opening Statements, Exhibits and Evidentiary Foundations, Cross Examination, Impeachment, Closing arguments, Opposing Strategies, and Sentencing Considerations. This program's training emphasis will be on Sexual Assault. The Target Training Audience is: Tribal Court Judges, Tribal Court Prosecutors, and Tribal Court Public Defenders. Training Partners include: BIA Division of Courts, DOJ U.S. Attorney's Offices, DOJ Access to Justice Initiative, United States Office of Defender Services, Montana Department of Justice, Office of Victim Services, with Federal Public Defenders Office and DOJ National Indian Country Training Office.

Cost: Tuition is Free; Participant's Agency is responsible for Travel, Lodging, and per Diem costs associated with attending this program.
