**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL  
DETERMINATION RETURNING BOND POSTED BY RESPONDENTS VIZIO, INC.  
AND AMTRAN TECHNOLOGY CO., LTD.**

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 36) granting a joint motion filed by complainant and respondents Vizio, Inc., AmTran Technology Co., Ltd., and Suzhou Raken Technology, Ltd. (collectively, "the Vizio respondents") to release and return the bond posted by the Vizio respondents.

**SUPPLEMENTARY INFORMATION:** The Commission instituted the underlying investigation on November 15, 2007, based on a complaint filed by Funai Electric Co., Ltd. of Japan and Funai Corporation of Rutherford, NJ (collectively "Funai"), alleging violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital televisions and certain products containing same by reason of infringement of certain claims of United States Patent Nos. 5,329,369 and 6,115,074 ("the '074 patent"). 72 Fed. Reg. 64240 (November 15, 2007). The complaint named numerous respondents. On April 10, 2009, the Commission found a violation of section 337 with respect to the '074 patent. The Commission issued a limited exclusion order and several cease and desist orders.

On September 11, 2009, the Commission instituted an enforcement proceeding based on an enforcement complaint filed by Funai, alleging that certain respondents, including the Vizio respondents, have violated the Commission's limited exclusion order and cease and desist orders. 74 *Fed. Reg.* 46793.

On June 29, 2010, Funai and the Vizio respondents filed a joint petition to return the bond amounts posted by the Vizio respondents in connection with this investigation, pursuant to 19 C.F.R. § 210.50 (d). No party opposed this motion.

On August 3, 2010, the ALJ granted the joint motion and issued the subject ID ordering release and return of the bond amounts to the Vizio respondents. No petitions for review were filed. The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
