**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN  
INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO  
CERTAIN RESPONDENTS AND ISSUANCE OF CONSENT ORDER**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 18) of the presiding administrative law judge (“ALJ”) terminating the above-captioned investigation as to YXLON International GmbH (“Yxlon GmbH”) and YXLON International, Inc. (“Yxlon Inc.”) based on a consent order and a settlement agreement.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on July 16, 2009 based on a complaint filed on May 28, 2009, by Cognex Corporation of Natick, Massachusetts and Cognex Technology & Investment Corporation of Mountain View, California (collectively “complainants”). 74 *Fed. Reg.* 34589-90 (July 16, 2009). The complaint, as amended on June 26 and July 1, 2009, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain machine vision software, machine vision systems, or products containing same by reason of infringement of certain claims of U.S. Patent Nos. 7,016,539; 7,065,262; and 6,959,112. The complaint further alleges that an

industry in the United States exists as required by subsection (a)(2) of section 337. The complaint names numerous respondents including Yxlon GmbH of Germany and Yxlon Inc. of Mogadore, Ohio (collectively “the Yxlon respondents”).

On September 14, 2009, complainants and the Yxlon respondents moved to terminate the investigation as to these respondents on the basis of a consent order and a settlement agreement. The Commission investigative attorney filed a response in support of the motion.

The ALJ issued the subject ID on October 29, 2009, granting the motion for termination. He found that the motion for termination satisfies Commission rules 210.21(b), (c)(ii), and (c)(3)(i). He further found, pursuant to Commission rule 210.50(b)(2), that termination of this investigation as to the Yxlon respondents by consent order and settlement agreement is in the public interest. No party petitioned for review of the ID. The Commission has determined not to review the ID.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, and in sections 210.21 and 210.42(h) of the Commission’s Rules of Practice and Procedure, 19 C.F.R. §§ 210.21, 210.42(h).
