SUBJECT: Command Policy Memorandum #15, Environmental Management System

1. References:

- d. The Army Strategy for the Environment, "Sustain the Mission, Secure the Future," 1 October 2004.

2. Purpose: To establish command policy for the implementation of the EMS in compliance with International Organization for Standardization (ISO) 14001 requirements and Army Policy that supports environmental programs ensuring a sustainable training environment.

3. Applicability: This policy applies to all U.S. Army Garrison, Presidio of Monterey (USAG, POM), Ord Military Community (OMC), Satellite Communication (SATCOM) Station, Camp Roberts personnel and active component units, agencies, activities and contractors working at USAG, POM, as well as off-post units/agencies utilizing USAG, POM facilities.

4. Proponent: The proponent for this policy memorandum is the Directorate of Public Works. This policy supersedes previous policy dated 30 July 2009.

5. The mission of the USAG, POM is to provide first class infrastructure and services to support mission readiness and enhance the quality of life for the Monterey Military Community and its Families. In accomplishing our mission, we commit to:

- a. Comply with all applicable environmental policy, laws and regulations.
- b. Continually assess activities and services to determine their effect on the environment. Identify the significant environmental impacts and ensure that they are considered when establishing objectives and targets in our environmental management programs.

c. Identify potential sources of pollution and meet or exceed Army and USAG, POM goals for prevention of pollution.

d. Strive for fully integrating the relevant environmental requirements into our mission procedures and work practices so that environmental awareness and compliance are a routine part of the way we perform activities and services.

e. Actively implement the standards and seek opportunities to continually improve our EMS. Establish measures of performance to assist in assessing system effectiveness.

6. This policy is effective immediately. Supervisors will ensure that copies of the policy are posted in a conspicuous location in the work areas and offices.
