MEMORANDUM FOR Fort George G. Meade Residents and Guests

SUBJECT: Fort George G. Meade Policy Memorandum # 69, On-Post Curfew for Juveniles

References:

- a. AR 190-13, The Army Physical Security Program, dated 3 September 2009
- b. AR 420-1, Army Facilities Management, dated 28 March 2009
- c. Picerne Housing Resident Responsibility Guide, dated December 2008
- 2. No person 17 years of age or younger (hereinafter "minors") may be in a public place on Fort George G. Meade after 2200 (10:00 pm) Sunday through Thursday or 2300 (11:00 pm) Friday and Saturday, or before 0500 (5:00 am), with the following exceptions:
 - a. Any minor accompanied by his or her parent or adult guardian.
- b. Any minor going to or returning from his or her place of employment must be carrying a note signed by his or her guardian explaining the circumstances, by identifying the work location and hours. They must also have the ability to produce an address and phone numbers for verification. Such minors must proceed directly from work to home or home to work without detour or delay.
- c. Any minor attending or returning from an on-post school, religious or authorized recreational activity supervised by responsible adults, or returning from off-post events. Such minors will carry a note signed by their guardian, explaining the circumstances, stating the event location and hours and containing an address and phone numbers for verification. These minors must proceed directly from the event to home or home to the event without detour or delay.
- 3. Minors who do not live on post who arrive at an installation gate during curfew hours without escort may be denied access to the post. Minors who live in on-post quarters who arrive at an installation gate during curfew hours without escort will proceed directly to their quarters without detour or delay.
- 4. First time violators will be taken to the Directorate of Emergency Services (DES) where parents or adult guardians will be notified and required to take control of the minor(s) in question.

Repeat violators will be processed as curfew violators, reported in the daily Military Police Blotter (DA FM 3997) and will be required to appear before the Juvenile Misconduct Review Board (for military dependents) or will receive an Anne Arundel County In-Take form (for non-DoD affiliated minors). Upon having received either of these notifications, the minor and their parents or adult guardian will be required to attend the proceedings outlined on the notification.
- 6. DES will notify the Garrison Commander of the offense. Curfew violations may reflect negatively and/or provide evidence of misconduct on the part of sponsors and their Families who reside in on-post housing. The DES will schedule a meeting with the sponsor of the juvenile and a unit representative for repeat offenders. A recommendation by the DES may be forwarded to the Garrison Commander to have the minor barred from the installation for any further misconduct. The DES may also make a recommendation for the Family to be removed from family housing, if applicable.
- 7. This policy does not apply to active service members or spouses who are under 18 years of age.
- 8. This policy letter is punitive for all Soldiers who reside on or are assigned to Fort George G. Meade. Soldiers that violate this policy by allowing curfew violations by minors under their care (including guests) may be subject to adverse action, face nonjudicial punishment, or judicial punishment under Article 92, UCMJ.
- 9. The proponent for this policy is the DES, Police Services Division.
