WESTERN PACIFIC REGIONAL FISHERY MANAGEMENT COUNCIL NOMINATION RATIONALE

The following nominees are individuals who, by reason of their occupation, experience, scientific expertise, training, or interest, are knowledgeable of Hawaii's fishery resources.

Michael (Mike) Kunio Goto is a commercial and recreational fisherman, who in his position with the United Fishing Agency, works closely with the entire local fishing industry. He has dealt with the commercial fisheries sector, including the longline, shoreline, handline, trolling, shallow-set swordfish, and bottomfish fisheries. Mr. Goto is also a member of the Hawaii Longline Association. Over the past five years, he has participated in the Western Pacific Regional Fishery Management Council's fisheries forum, advisory panels, plan team, SSC, and Council meetings.

<u>Jiro John Kaneko</u>, a project director for Pacific Management Resources, Inc., has provided technical assistance in fisheries, seafood quality and control, fish processing, marketing and research on seafood safety issues for over 16 years. He is also engaged in continuing fisheries research, outreach and education efforts. Mr. Kaneko has served as a Pelagic Plan Team Member for the Western Pacific Regional Fishery Management Council, and was the Hawaii Representative for the Pacific Fisheries Technologists (1991-1994 and 1998-2000). He also was a member of the Science and Technology Committee of the National Fisheries Institute.

Edwin Ebisui, Jr., is a lawyer who has been interested in fisheries-related matters for years. Mr. Ebisui, who previously served three terms on the Council, is a part-time commercial fisherman who also fishes recreationally. He was elected president of the Pacific Ocean Research Foundation, a non-profit organization dedicated to research and knowledge of Pacific game fish.
