- Alaska: Russ Kirkham. Chuitna project SMCRA permit coming in for review. Companies continue to explore as demand continues.
- Colorado: Sandy Brown. Conducting areal inspections. Processing Phase I bond release for Seneca Mine.
- Montana: Angela McDannel. Some auger highwall mining is being conducted. Survey grade RTK unit being applied at several mines to establish a universal coordinate system for area that has local coordinate systems. New vegetation specialist has been hired.

- New Mexico: David Clark. Permit application for Carizzo project expected. Dave will distribute information regarding a native seed harvester. This type of technology may be very valuable in developing seed mixtures for reclamation.
- North Dakota: Jim Deutsch. Guy Welch will participate as the WRTT representative for ND. Falkirk mine added approximately 5000 acres to the permit application. Bond release applications have been submitted and will be evaluated in the spring.
- Utah: Amber Fortner. Several GOB vent holes are being reviewed for adequacy as part of the ventilation system.
- Wyoming: Marcelo Calle. Hydrology group is taking a closer look at the surface water / ground water relationship component for bond release. Staff has also been busy evaluating the GIS component of applications as part of the WDEQ enterprise GIS environment though the use of ArcGIS Server and ArcSDE.

- Denver Field Division: Howard Strand. A revised reclamation schedule is being pursued at Centralia Mine.
