WRTT Member Reports/Information

Alaska: Russ Kirkham: He stated that things have been very busy. The

petition for lands unsuitable (concerning the proposed Chuitna mine) was rejected. Bob Postle and Glenn Waugh (OSMRE) traveled to Alaska and evaluated the Chuitna mines chances for

successful reclamation.

Colorado: Sandy Brown: There are 6-7 ongoing bond releases. She noted

that there had been revisions in the post mining land use (PMLU) on some of these sites. Vegetative sampling was taking place on bond forfeiture sites. The state of CO plans to hire a new person,

possibly by the end of next month.

Montana: Angela McDannel: Montana is proceeding with a Phase IV bond

release. Steve Regele's former position is to be filled. The

position will now be called a "Technical Coordinator".

New Mexico: David Clark: The La Plata mine is undergoing a PMLU change.

Part of the mine will be used for county facility use (+/-100 acres).

A BLM land swap was involved.

North Dakota: Guy Welch/Craig Nelson: Two new permits are being issued.

One of these permits will be close to 5,000 acres (Falkirk Mine). An NOV was issued at an unnamed coal mine. The soil scientist

position has not yet been filled.

Utah: Steve Fluke: The Southern Utah Wilderness Alliance (SUWA) is

challenging the Lila Mine permit. A GIS person will be filling

Amber's recently vacated position.

Wyoming: Marcelo Calle: A lot of permitting and mining going on in the

uranium/bentonite/gravel fields. Carbon basin mine submitted a (hopefully) minor revision. Ash Creek mine had an amendment to their permit. There were possible AVS issues with this mine. The Bridger mine, as well as the west gas fields, is planning on

using the natural regrade program.

ABQ Field Office: Rick Holbrook. No report.

Casper Field Office: Alan Boehms. No Report.

Denver Field Division: Howard Strand. The DFD continues to mentor two

interns. Their names are Elizabeth Schaeffer and Christine

Belka. The TransAlta Mine in Centralia WA has been issued a

Show-Cause Order. TransAlta's motion to vacate the order was denied and a pre-hearing conference is scheduled for July 26, 2007. In the meantime, TransAlta has agreed to begin settlement talks with DFD. Initial talks are scheduled for August 7 and 8, 2007 in Olympia. Counsel for the company and the Regional Solicitor have discussed a joint motion to not set a hearing pending the outcome of the settlement negotiations.

Western Region Program Support Division: Karen Jass: The Absaloka mine (North) has submitted a revision. The McKinley mine is using the natural regrade program for some of its reclamation. The Navajo mine is continuing its public hearing concerning the Desert Rock power plant. The Black Mesa mine is closed at this time. The Kayenta mine is considering using some of the coal from the Black Mesa Mine. The John Henry Mine had a revision submitted to all fill material to be placed on the permit. Bonding software can be downloaded from the OSM website.
