**I. INSTRUCTIONS.** Prepare in two copies. MASA Guard will return one copy as a receipt.

THIS COPY MUST BE RETURNED TO WITHDRAW THE VEHICLE(S) FROM THE VHA. Two fire extinguishers rated 10 BC or more are required to transport ammunition. CAT I and CAT II material must be in the constant custody of a SGT or above. Armed guard is required for CAT I.

- c. Noncompatible ammunition/explosives are not stored on the vehicle(s); live ammunition/explosives are not stored with residue and packing materials.
- d. Correct Department of Transportation (DOT) and/or Fire and Chemical Hazard Symbols are properly displayed on the vehicle(s).
