Thank you for your letter of April 18, 1996, which responded to the comments and recommendations from our June 1995 review of the Washington radiation control program. We appreciate the positive actions that you and your staff are implementing with regard to our comments and recommendations. In particular, we are pleased to learn that you have drafted procedures and have created a database for tracking incidents. Moreover, we are pleased with your actions in addressing the "Inspection Procedures" indicator recommendations.

We would like to specifically acknowledge your response to our decision to withhold a finding of compatibility based upon the effective date of amendments to 10 CFR Part 34.20. Your response indicated that it would not be cost beneficial to change your implementation date and that changing the implementation date is not a fundamental public health and safety issue. We recognize your position. However, under current compatibility procedures, we have no basis to modify our earlier decision to withhold compatibility. This finding will remain in effect until the rule is implemented or until the Washington program compatibility is reassessed after the implementing procedures for the Policy Statement on Adequacy and Compatibility of Agreement State Programs are approved by the Commission.

We will review the status of your activities as a part of our next program review.
