To satisfy the reporting requirements of WCPFC Conservation and Management Measures 2005-03 (North Pacific albacore) and 2006-04 (South Pacific striped marlin), included in Attachment 1 is the following information:

- (1) for the latter half of 2008 and for each of 2007 and 2008, U.S. catches of albacore north of the equator in the Pacific Ocean;
- (2) for each of the years 2004 through 2008, estimates of U.S. fishing effort north of the equator in the Pacific Ocean in fisheries directed at albacore; and
- (3) for 2007 and 2008, the number of, and catches by, U.S. vessels that fished for striped marlin, and bycatch of striped marlin, south of 15°S in the Convention Area.¹
