**F. Discussion of Other FOIA Activities (Optional)**

The disposition of partial grants reflected in chart B. (1) are due to denial of third party information pertaining to privacy and investigative requests. RMA continues to process more privacy information regarding individual agricultural producers compared to Agency program information. Fraudulent farm practices in the program require complex compliance investigations and as a result generate requests pertaining to compliance cases which often have third party information needing redacting.
