<u>Budget/Costs Status:</u> The project continues to progress as NS has made the necessary adjustments to control the project budget. Construction requirements have been tailored throughout the project to help maximize efficiency and reduce costs while maintaining quality and safety standards. A revised budget has been incorporated into the Estimate to Complete column in the table below. The Financial Plan Update has been posted on the project website.

Reasons for difference between Baseline Budget and Estimate to Complete:

4/19/07 - \$1,108,179 was removed on a prorated basis from both the VA and WV federal participating and WV non-participating rows. This amount was for the planning work completed prior to the MOA and is now included in the Misc. amount. This was done to better correspond with Norfolk Southern's project accounts. Estimate to Complete total is \$263,179 higher than the January 2007 baseline due to higher actual costs for planning and higher estimates for the preliminary engineering for the Ohio bridge work.

1/23/09 – The Estimate to Complete was revised based on a revised project budget prepared by NS and approved by the NS Board of Directors in November 2008. The overall increases in the budget were due to increased constructions costs. In an effort to reduce total costs, some of non-clearance related work in Kentucky and West Virginia has been cancelled. This resulted in a lower estimated cost for the work with no federal participation.

Work Completed:

- ✓ Project Funding: EFLHD has authorized all of the Section 1702 funds and nearly all of the Section 1301 funds. As the project gets closer to the scheduled completion date of June 2010, EFLHD will issue a final authorization to NS utilizing any remaining funds.
- ✓ Preliminary Engineering: Final Plan Approval was issued for Big Sandy #3 and Big Sandy #4 Tunnels on July 30, 2009. All tunnel work has now received Final Plan approval.
- ✓ *Kentucky Work:* All structural modification work is complete. Trackwork remains.
- ✓ *Ohio Work:* All clearance work in Ohio has been completed.
- ✓ *Virginia Work:* All Clearance work in Virginia has been completed.
- ✓ West VA Work:

All through truss bridge modifications are complete. All signal replacements are complete. Slide fence modifications: 4 out of 8 are complete. Track work: 12 out of 23 tunnels are complete. Structural modifications: 15 out of 20 tunnels are complete.

Work-In-Progress:

- Project Funding: EFLHD is working to get prior year carryover Section 1301 funds reinstated.
- Preliminary Engineering: The Railroad has reached an agreement with the City of Bluefield to remove the Belcher\Harding Street Bridge instead of raising the bridge. Plans are being completed by the Railroad for this work.

- Contractor Pre-Qualification: RFPQ #10 was posted on the WVDOT website on November 1, 2009. This request for qualifications covers the removal of the Belcher\Harding Street Bridge in Bluefield, WV. Qualification statements are requested by November 30, 2009.
- > Tunnel Construction:

Construction was completed on May 13, 2009 at Vaughan, Roderfield, Laurel, and Gordon Tunnels in WV. Trackwork to be completed by the Railroad at Laurel and Gordon.

Construction was completed on May 5, 2009 at Twin Branch 1 & 2 and Antler 1 & 2 Tunnels in WV. Trackwork completed by the Railroad on September 18, 2009.

Construction was completed on April 22, 2009 at Hemphill 1 & 2 Tunnels in WV. Trackwork completed by the Railroad on August 6, 2009.

Construction was completed on July 23, 2009 at Welch Tunnel in WV. Trackwork to be completed by the Railroad.

Construction is underway at Cooper Tunnel in WV. Current construction activities include removing existing liner, installing steel sets, and grouting behind sets. Work is approximately 11% complete.

Construction was completed on September 3, 2009 at Big Four No. 1 & 2, and West Vivian Tunnels in WV. Trackwork to be completed by the Railroad.

Construction was completed on September 23, 2009 at Glen Alum Tunnel in WV. Trackwork to be completed by the Railroad.

Construction was completed on September 3, 2009 at Hatfield No. 2 Tunnel in KY. Trackwork is in progress by the Railroad.

Construction is underway at Big Sandy #1 Tunnel in WV. Current construction activities include removing existing liner, installing portal spiles, and pre-drilling for roof bolts. Work is approximately 12% complete.

Construction is underway at Williamson Tunnel in WV. Current construction activities include removing existing liner and pre-drilling for roof bolts. Work is approximately 30% complete.

Johnson Western Constructors was the low bidder for the Big Sandy #3 Tunnel in WV. A contract was awarded on July 16, 2009 for \$5,945,463. A Pre-Construction Meeting was held on September 3, 2009. Current construction activities include liner removal, installing sidewall bolts, and pre-drilling crown. Work is approximately 15% complete.

R.J Corman was the low bidder for the Big Sandy #4 Tunnel in WV. A contract was awarded on August 31, 2009 for \$4,628,272. A Pre-Construction Meeting was held on

September 24, 2009 and work started on October 5, 2009. Current construction activities include repairing sidewalls for steel sets and grouting.

Historical Preservation: Historical Roadside Marker in Virginia has been installed. The installation of interpretive signs in West Virginia is being coordinated with the Coal Heritage Highway Authority. An amendment to the MOA addressing the removal of the Belcher\Harding Street Bridge in Bluefield, WV has been coordinated with the SHPOs and is currently being distributed for signatures.

<u>Project Schedule/Status:</u> The Clearance Project is on schedule for completion in the summer of 2010. Norfolk Southern continues to review the schedule and make adjustments to tunnel and trackwork sequencing to ensure that both the project and train operations are maximized. The final designs for all the tunnels have been completed and prequalified contractors have been solicited for bids. Structural modifications have been completed in 17 tunnels to date with 5 tunnels remaining to be completed. NS will continue to complete the trackwork as the structural modifications are completed.
