### Critical Issues:

Federal Funds - Have not received Fiscal Year 2009 Section 1702 funds.

<u>Budget/Costs Status:</u> The project continues to progress as NS has made the necessary adjustments to control the project budget. Construction requirements have been tailored throughout the project to help maximize efficiency and reduce costs while maintaining quality and safety standards. A revised budget has been incorporated into the Estimate to Complete column in the table below. The Financial Plan Update, which incorporates the revised budget, was completed on June 30, 2009. The update was distributed on July 7, 2009 and will be posted on the project website.

Reasons for difference between Baseline Budget and Estimate to Complete:

4/19/07 - \$1,108,179 was removed on a prorated basis from both the VA and WV federal participating and WV non-participating rows. This amount was for the planning work completed prior to the MOA and is now included in the Misc. amount. This was done to better correspond with Norfolk Southern's project accounts. Estimate to Complete total is \$263,179 higher than the January 2007 baseline due to higher actual costs for planning and higher estimates for the preliminary engineering for the Ohio bridge work.

1/23/09 – The Estimate to Complete was revised based on a revised project budget prepared by NS and approved by the NS Board of Directors in November 2008. The overall increases in the budget were due to increased constructions costs. In an effort to reduce total costs, some of non-clearance related work in Kentucky and West Virginia has been cancelled. This resulted in a lower estimated cost for the work with no federal participation.

### Work Completed:

- ✓ Project Funding: In a Letter of Authorization from EFLHD dated July 9, 2009, the funds authorized under Section 1301 were increase by \$16,813,444 which increases the amount authorized for all activities in West Virginia to \$80,039,283. These funds represent nearly all of the Section 1301 funds available for the project. As the project gets closer to the scheduled completion date of June 2010, EFLHD will issue a final authorization to NS utilizing any remaining funds.
- ✓ *Ohio Work:* All clearance work in Ohio has been completed.
- ✓ *Virginia Work:* All Clearance work in Virginia has been completed.
- ✓ West VA Work:

All through truss bridge modifications are complete. All signal replacements are complete. Slide fence modifications: 4 out of 8 are complete. Track work: 3 out of 23 tunnels are complete. Structural modifications: 11 out of 20 tunnels are complete.

# Work-In-Progress:

- Project Funding: VDOT has requested that the Section 1702 funds for Fiscal Year 2009 be transferred to EFLHD. Once the funds are received, a Letter of Authorization will be issued for approved work in VA. FY 2009 is the final year for the distribution of funds that were included in SAFETEA-LU.
- Preliminary Engineering: Final Plan Approval was issued for Big Sandy #1 and Williamson Tunnels on May 15, 2009. On June 3, 2009 100% plans were distributed for Big Sandy #3 Tunnel. On July 24, 2009 100% plans were distributed for Big Sandy #4.

# > Tunnel Construction:

Construction was completed on May 13, 2009 at Vaughan, Roderfield, Laurel, and Gordon Tunnels in WV. Trackwork to be completed by the Railroad.

Construction was completed on May 5, 2009 at Twin Branch 1 & 2 and Antler 1 & 2 Tunnels in WV. Trackwork to be completed by the Railroad.

Construction was completed on April 22, 2009 at Hemphill 1 & 2 Tunnels in WV. Trackwork to be completed by the Railroad.

Construction was completed on July 23, 2009 at Welch Tunnel in WV. Trackwork to be completed by the Railroad.

Construction is underway at Cooper Tunnel in WV. Current construction activities include grouting and bolting. Work is approximately 5% complete.

Construction is underway at Big Four No. 1 & 2, and West Vivian Tunnels in WV. Current construction activities include notching and liner removal. Work is approximately 30% complete.

Johnson Western Constructors was the low bidder for the Glen Alum Tunnel in WV. A contract was awarded on May 13, 2009 for \$2,359,130. The Contractor started work on June 1, 2009. Current construction activities include installing rockbolts. Work is approximately 5% complete.

Johnson Western Constructors was the low bidder for the Hatfield No. 2 Tunnel in KY. A contract was awarded on May 13, 2009 for \$2,851,740. The Contractor started work on June 1, 2009. Current construction activities include notching and shotcrete. Work is approximately 5% complete.

Johnson Western Constructors was the low bidder for the Big Sandy #1 Tunnel in WV. A contract was awarded on June 9, 2009 for \$8,849,975. A Pre-Construction Meeting was held on July 1, 2009 with an anticipated start date of July 13, 2009.

Johnson Western Constructors was the low bidder for the Williamson Tunnel in WV. A contract was awarded on July 16, 2009 for \$4,169,140. A Pre-Construction Meeting was held on July 15, 2009 with an anticipated start date of August 3, 2009.

A request for bids for Big Sandy #3 Tunnel was issued on June 23, 2009 with bids due on July 8, 2009. Bids have been received but a contract has not been awarded yet.
