



Why This Matters

The *American Recovery and Reinvestment Act* (Recovery Act) appropriated \$1 billion to the Transportation Security Administration (TSA) for buying and installing baggage and passenger screening equipment at airports. This is one of a series of audits that we are performing to help ensure that Recovery Act funds were used for authorized purposes.

The objective of this audit was to determine whether funds invoiced by the City of San Antonio (the City) to support installation of a checked baggage screening project at the San Antonio International Airport were allowable, allocable, and reasonable. +

We did not require a response to this report. +

Review of Costs Invoiced Under an Agreement with TSA for a Checked Baggage Screening Project at San Antonio International Airport

What We Determined

We determined that costs of \$8,994,816 invoiced by the City under agreement no. HST04-09-H-REC168 were allowable, allocable, and reasonable for reimbursement. Also, we verified that the City complied with requirements for submitting quarterly reports to the federal government; for using American iron, steel, and manufactured goods in construction of the project; and for paying prevailing wages to contractor employees. +
