DS Logon

What is DS Logon?

DS Logon is a secure, self-service logon ID that allows Beneficiaries affiliated with the Department of Defense (DoD) or the Department of Veterans Affairs (VA) access to several websites using a single username and password.

The username is automatically generated by the system, and the password is chosen by you.

Who is eligible for a DS Logon?

- Service Members (Active Duty, Guard/Reservists)
- Retirees
- Veterans
- Spouses
- Eligible Family Members (18 or over)

How do I get started?

STEP 1: REQUEST AN ACCOUNT

ONLINE

If you have a Common Access Card (CAC) or DFAS myPay Login ID, you may request a DS Logon Account online for yourself and eligible family members by accessing the DS Logon Self-Service website.

OR

AT A DESIGNATED FACILITY

If you do not have a CAC or DFAS myPay Login ID, your identity must be confirmed in person at a participating VA Regional Office.

If you are getting a new ID card issued and you are affiliated with the DoD, you can visit a RAPIDS location. You can locate the nearest RAPIDS facility at:

What documentation do I need to bring?

You will need to bring at least 2 forms of approved documentation to confirm your identity. One must be a government-issued photo ID.

If you are affiliated with the VA and your address recently changed, it is recommended to bring a recent utility bill, phone bill, or credit card statement reflecting your current address.

STEP 2: ACTIVATE YOUR ACCOUNT

A confirmation letter will be mailed within 5-12 business days with your activation PIN. Once received, activate your account online by accessing the DS Logon Self-Service website.

This step does not apply if requesting an account with a CAC.

STEP 3: ESTABLISH YOUR PASSWORD

Your DS Logon password should be a minimum of 9 characters, numbers, or special characters. The password must be reset at least once every 150 days.

STEP 4: SELECT CHALLENGE QUESTIONS

To complete the activation process, you must select five challenge questions from a list provided by the system. If at some point in the future you forget your username or password, correctly answering three of these challenge questions will allow you to retrieve your username or password.



How long is my DS Logon valid?

Your DS Logon is valid for as long as you have an active affiliation with the DoD or VA.
