
Internet Assisted Review (IAR) Version 3.3.2.4 Release Notes

NOTE: eRA has been working on improving the performance of database transactions. With the updates made, users should expect to see positive changes in performance while saving scores.

New Features

New Error Message When Saving an Unchanged Voter Sheet

A new error message displays on the *Voter Sheet* when a save is attempted but no changes have been made. The message displays after selecting the **Save All** link, **Save All** button, or **Save and Return** button and is as follows:

There are no changes to save.

Fixes

Slow System Response Time Fixed

Previously, users were reporting a slow system response when accessing the *List of Meetings* and *Import Meeting Materials* screens.

Resolution

This issue has been resolved. Users should no longer experience slowness when retrieving these screens.

Post-Meeting COI Form Link Displays After Meeting Begins

The **Post-Meeting COI Form** link in the *List of Meetings* should only display in IAR after the start of a meeting. Previously, the system ignored the meeting start time, considering only the start date of the meeting, when enabling the link. This resulted in the post-meeting Conflict of Interest (COI) form being accessible prior to the start of the meeting.

Resolution

This issue has been fixed. The IAR system has been modified to consider the start date and time of a meeting before enabling the **Post-Meeting COI Form** link. Reviewers are not able to access this link until after the start of the meeting.

eCOI Post-Meeting Reminder E-mail Now Sent After End of Meeting

Previously, the eCOI post-meeting reminder e-mail was sent to users early on the day the meeting ended. In most cases, this was before the meeting actually started.

Resolution

This issue has been fixed. The eCOI post-meeting reminder e-mail is no longer sent the day the meeting ends. The reminder is now sent during the night after the end date of the meeting.

Timestamp Removed from Post-Meeting COI Form Signature Field

Previously, when a Reviewer electronically signed the post-meeting COI form, the **Signature** line included the date and time on which the form was signed. Although the date should be captured in this field, the time should not be.

Resolution

The form has been amended. The time at which a Reviewer electronically signs the form no longer displays in the **Signature** line. Only the Reviewer's name and sign-off date display.

Updated Link Names for Pre-Meeting COI Reports

The name of the links for two reports in IAR has changed to reflect the true content of each report. **Pre-meeting COI Form-Page 2-3 (non-Fed)** and **Pre-meeting COI Form-Page 2-3 (Fed)** links are now called **Pre-meeting COI Form-Page 2-4 (non-Fed)** and **Pre-meeting COI Form-Page 2-4 (Fed)**.

SROs see these links on the *Track Conflict of Interest Forms* screen while Reviewers see them on the *Pre Meeting Form* screen.
