NOAA Seeking Public Comment on Long-Term Measures to Address Overfishing and Bycatch in the Gulf of Mexico Red Snapper and Shrimp Fisheries

NOAA Fisheries Service and the Gulf of Mexico Fishery Management Council (Council) are seeking comments from the public on proposed long-term regulatory measures to address overfishing and bycatch in the Gulf of Mexico directed red snapper and shrimp fisheries. The status of this population is influenced not only by fishing mortality rates in the directed commercial and recreational fisheries but also by red snapper bycatch mortality rates in the shrimp trawl fishery. A recent assessment indicates red snapper catch and bycatch levels in the directed red snapper and shrimp fisheries are likely to jeopardize the success of the latest plan to end overfishing of red snapper and rebuild the population to sustainable levels. Therefore, long-term regulatory measures have been proposed for these fisheries.

Please comment on the following proposed regulatory measures:

- Revising the red snapper rebuilding plan and reducing the total allowable catch (TAC) for red snapper.
- Establishing measures to constrain recreational harvest to the recreational quota associated with a new TAC

- Assuming a post-hurricane reduction in fishing effort/landings when setting TAC.
- Setting a bag limit for for-hire captain and crew.
- Modifying the commercial minimum size limit to reduce bycatch in the directed red snapper fishery.
- Establishing fishing gear requirements, such as circle hooks, minimum hook sizes, venting tools, and dehooking devices, to reduce bycatch and/or bycatch mortality in the directed red snapper fishery.
- Establishing a target reduction goal for juvenile red snapper mortality in the shrimp fishery.
- Managing shrimp fishing effort through seasonal area closures to control effort and reduce red snapper mortality.
- Establishing a procedural mechanism for the Council to quickly respond to information indicating shrimp effort is above target levels.

The proposed regulatory measures and the Council's preferred management measures are described in further detail in the Draft Supplemental Environmental Impact Statement (DSEIS) for Joint Amendment 27 to the Reef Fish Fishery Management Plan and Amendment 14 to the Shrimp Fishery Management Plan (Amendment 27/14). The Environmental Protection Agency announced the availability of the DSEIS on April 20, 2007 (72 FR 19927).

The regulatory measures evaluated in this DSEIS may be implemented through Amendment 27/14 and are meant to eventually replace the recent temporary (interim) measures implemented by NOAA Fisheries Service. Public hearings for Amendment 27/14 will be held May 14-24, 2007, throughout the Gulf of Mexico. The Council is scheduled to take final action on this amendment at the June 4-8, 2007, meeting in New Orleans, Louisiana, and make a recommendation to NOAA Fisheries Service as to which proposed long-term measures to implement.
