Mitigation Banks


- Wetland mitigation banks provide wetland credits for sale and may have credits available at any time.
- The Corps of Engineers must approve all mitigation proposals, including mitigation banks.
- **Primary Service Area**: if your impacts are within this area, mitigation will generally be a 1:1 ratio.
- Secondary Service Area: if your impacts are within this area, mitigation will generally be greater than a 1:1 ratio.


Mile High Wetland Mitigation Bank


Riverdale Wetlands Mitigation Bank




Warm Springs Wetland Mitigation Bank
