Welcome to the third issue of our newsletter. We are pleased to share some of our accomplishments. During the month of April HUD provided fair housing training in Riverton and participated in the

Wind River Pathways Homeownership Fair. The Casper Field Office Director served as a Resource Team Member for Wyoming Rural Development Council's two-day assessment of the town of Alcova. The team of experts suggests ways for rural communities to accomplish local development efforts. HUD and Fannie Mae provided a reverse mortgage

training to lenders, housing counseling agencies, and nonprofit organizations serving the elderly in Cheyenne. Our staff participated in the annual Faith in Action Forum. Sessions were conducted dealing with at risk kids, the elderly, strengthening marriage and families, and prisoner reentry. During the month of June our office Director Chris Stearns was deployed to Kuwait/Irag. He is a member of the Air Force Reserves. We wish him a safe return in August. Lyle Konkol from the Montana HUD Office has volunteered to cover for Chris until his return. The Casper staff thanks Lyle for his assistance and his efforts in continuing HUD's mission. He will be conducting several reverse mortgage trainings throughout the state. The Acting Director attended the WY Housing Network's first Board of Directors retreat. He provided information on ways to leverage resources and locate matching dollars when applying for grants.
