Easter Seals - Wyoming Breaks Ground on HUD 811 Supportive Housing Development in Sheridan





Easter Seals of Wyoming held a ground breaking for their HUD Section 811 – Supportive Housing project in Sheridan on May 29, 2009. The \$2 million project, supported in part by a HUD \$1,837,748 million grant and \$205,500 rental subsidy, will provide 10 units to citizens of Sheridan and surrounding area. Dan Carmon, Casper Field Office Director, spoke of their achievement in meeting the community needs and the partnerships formed to reach the achievement, such as the City of Sheridan's commitment and Homer A. & Mildred S. Scott Foundation's generous financial contribution to the project. Michelle Belknap, Easter Seals President & CEO, commended Laurie Mohney, Sr. VP-Dev., for her tireless efforts to make the achievement possible. Potential residents of the project broke ground as hundreds of balloons were released for the event.





When 50% Is Not Good Enough

Maria J. Rodriguez, Program Assistant suggested that the Casper Field Office can reduce paper consumption by re-using paper we print on. Ms. Rodriguez stated "...we discard paper that is half-used". Implementing her suggestion, the Casper Field Office now collates bundles of used printer and copy paper, blank side up, binds them with compressors and uses them for internal writing pads instead of the writing pads currently in inventory. While the estimated savings is small, every effort to conserve and reduce our operating cost is considered. Ms. Rodriguez received a Time-Off award for her suggestion.
